TB Free Village in a tum ber chu vantlang in relbawlina kawngah TB vanga harsatna thleng thin te sutkian anih theih nan leh khawtlang roreltu zingah TB umbona kawng a inelna thianghlim a awmtheihna tura hmalak a ni a. Tin an hmalaknate lo hlutsak a, lawmpui hi a tum a ni.
